

RELEASE AND WAIVER

The Ike Foundation, a New Jersey Non-Profit Corporation (the "**Foundation**") plans to host a Pro-Am Tournament on or about 06/01/24 in or around Northeast MD waterways and certain other activities and events related thereto (collectively, the "**Event**"). As a material inducement and a condition precedent to the Foundation agreeing to allow the undersigned to participate in whole or in part in the Event, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the undersigned hereby agrees and consents to the following terms, conditions and provisions.

The undersigned acknowledges, agrees and fully understands that there are inherent dangers in connection with the activities associated with or that may (voluntarily or involuntarily) take place during the Event including, without limitation, boating, fishing, swimming, water sports, water rescue, navigation around or through water hazards, and other activities and conditions associated with or that may occur (whether planned or unplanned) during or in connection with the Event (collectively, the "**Activities**") and that the risks associated with these Activities may be greater if poor weather, lightning or other hazardous conditions due to rough waters, presence of marine life forms and insects, other boat and large vessel traffic or debris in the waterways are experienced during or in connection with the Event.

Beyond the inherent dangers associated with the Activities, the undersigned also acknowledges, agrees and fully understands that the recent spread of the novel coronavirus ("COVID-19") presents additional risks to participation in the Event. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

The undersigned further acknowledges and understands that while the Foundation has put in place certain preventative measures designed to reduce the spread of COVID-19, the Foundation cannot guarantee that you will not become infected with COVID-19 as a result of your voluntary participation in the Event and/or the Activities. Further, merely attending the Event, regardless of whether you partake in the Activities, could increase your risk of contracting COVID-19 and later spreading it to others.

In addition to and without in any way limiting the below acknowledgment, by signing this agreement, I acknowledge and understand the contagious nature of COVID-19 and voluntarily assume the risk detailed above and that such exposure or infection may result in personal injury, illness, permanent disability, and death to myself or others that I come into contact with even after the Event. I further acknowledge and understand that the risk of becoming exposed to or infected by COVID-19 at the Event may result from the actions, omissions, or negligence of myself and others, including, without limitation, the Foundation and its Affiliates (as defined below).

I further acknowledge and understand that the Activities and the use of any equipment made available during the Event have inherent dangers and the use thereof and the participation in the Event and any Activities associated therewith requires physical exertion and I realize that there is a high level of risk of physical injury which may be incurred while engaging in these Activities. I hereby certify that I am in good physical condition and have adequate health insurance to cover any injury including, without limitation, any injury that may occur related to COVID-19, or that I may sustain during or as a result of participating in the Event or any associated Activities. I further certify that to the best of my knowledge I do not and am not suffering from any of the known symptoms of COVID-19 including, without limitation, cough, shortness of breath or difficulty breathing, fever, chills, muscle pain, sore throat, new loss of taste or smell, or gastrointestinal symptoms like nausea, vomiting, or diarrhea.

I agree to follow any and all instructions, recommendations and cautions of the Foundation or its agents at all times during the Event, including, without limitation, instructions for the prevention of the contraction and spread of COVID-19 as well as the operation of fishing equipment, boats, and personal flotation devices.

I, on behalf of me and my spouse, next of kin, personal representatives, heirs and beneficiaries, hereby agree to forever hold harmless, waive and fully release the Foundation and its Affiliates (as defined below) as well as the Foundation's and the Affiliates' respective sponsors, endorsers, officers, directors, shareholders, members, managers, officers, affiliates, employees, contractors, agents, attorneys, and staff (each a "**Released Party**" and, collectively, the "**Released Parties**") from and against any and all liability, losses, damages or claims whatsoever pertaining to my participation in the Event or any related Activities including, without limitation, bodily injury or death and whether or not caused by the negligence or other acts or omissions on the part of any of the Released Parties either related or unrelated to COVID-19. As used in this Agreement, "Affiliate" means Professional Edge Fishing, LLC, Michael Iaconelli and any person or entity who controls, is controlled by, or is under common control with the Foundation. I hereby consent to receive medical treatment which may be deemed necessary in the event of any illness, accident or injury or medical emergency resulting from or in connection with my participation in the Event or any related Activities and I understand that I am solely responsible for all costs related to such medical treatment and/or medical transportation.

I waive my insurers' right to make a claim against any of the Released Parties based on payments by insurers to me or on my behalf for any reason. This means my insurers have no rights of subrogation against any of the Released Parties. Furthermore, I hereby voluntarily agree and covenant not to sue any Released Party and voluntarily waive the rights to pursue any lawsuits or other legal redress against the Released Parties.

I hereby agree, jointly and severally, to pay and reimburse the Released Parties for all costs, damages and expenses that the Released Parties' suffer as a result of my failure to abide by the terms of this document including, without limitation, all attorneys' fees and other costs and expenses incurred by Released Parties in defending any action brought by or on behalf of any of the undersigned or in connection with the Released Parties' enforcement of this Release and Waiver. This document is governed by the laws of the State of New Jersey without giving effect to its conflicts of law provisions.
